



Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Chula Vista National Little League (“the League”) has put in place preventative measures to reduce the spread of COVID-19; however, the League **cannot guarantee** that you or your child(ren) will not become infected with COVID-19. Further, **attending the League and League events could increase** your risk and your child(ren)’s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending and/or participating in the League and League events and that such exposure or infection may result in personal injury, illness, permanent disability, physical and mental harm, pecuniary losses, medical expenses, loss of income, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the League may result from the actions, omissions, or negligence of myself and others, including, but not limited to League employees, officers, volunteers, coaches, managers, umpires, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any and all injury and losses to my child(ren) or myself including, but not limited to personal injury, illness, permanent disability, temporary disability, physical and mental harm, death, economic losses, medical expenses, loss of income, and all other damages, losses, and expenses of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)’s or my attendance at the League or participation in League programming (“Claims”).

On my behalf, and on behalf of my children, I hereby release, covenant not to sue, forever discharge, and forever hold harmless the League, Little League International, California District 42 Little League, **Chula Vista Elementary School District, the City of Chula Vista**, all sponsoring agencies, all sponsors and advertisers, all other participants of the League, the owners and lessors of the premises used to conduct League events, and all of their *officers, officials, employees, volunteers, agents and representatives*, and all other persons and entities, of and from all Claims and losses, including all liabilities, claims, actions, causes of action, losses, harm,

injuries, damages, costs and/or expenses of any kind arising out of or relating to the attending or participation in the League and League events. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the League, Little League International, California District 42 Little League, **Chula Vista Elementary School District, the City of Chula Vista**, its employees, agents, volunteers, officers, and representatives, whether a COVID-19 infection occurs before, during, or after attending or participating in any League program.
